
3.1 Introduction


The LT-20/LT-20P is a LoRa[®] compliant solar tracker. The LT-20 is a cattle tracker. The LT-20P is a compact asset tracker. Both of them have solar panel for charging by sunlight. They could be charged by DC power via charging cradle as well.



4. Device Operation

4.1 Device Charging



Using the device for the first time, rechargeable battery will require the proper charge before LT-20/LT-20P is operable. To maximize your device's battery life, proceed by performing the steps listed below.

- 1. Connect cradle to AC power adapter via micro USB cable.
- 2. Put LT-20/LT-20P to the charging cradle and red LED would be on while charging.
- 3. It should be charged at least 1.5 hours of battery charging time.

If you don't purchase charging cradle, you could put our device which solar panel face to proper sunshine to charge. It will take several days to be charged to at least 50% for the proper operation.



- 1. Please note the device will be charging by solar panel only when it's on.
- 2. When it is in standby mode, it could not join to network server and send any report.



4.2 Function Button



1. To turn the device "ON", press and hold the function button for 1 second and release the function button. Then the BLE LED would blink quickly.

There are two kinds of behavior as following table when the device is on.

Operation mode	Standby mode
Short press the function button, the BLE	Short press the function button, the BLE
LED would have a quick blink.	LED would have a slow blink.

- 2. To turn the device "OFF", press and hold the function button for around 5 to 6 seconds, you would see BLE LED would blink three times and then release the function button.
- 3. To do hardware reset, press and hold the function button for 11 seconds and release it.



4.3 Parameter Settings via iOS App

Install LT-20 App as the following link https://apps.apple.com/tw/app/lt-20/id1492856834
 from App store or QR code below. It would have icon as following.





- 2. Make sure you turn on BLE for mobile device and open LT-20 App.
- 3. After device turned on [short press function button for 1 second, the BLE LED will blink quickly for 5 seconds], press function button for 2 seconds, then BLE LED will blink twice and release function button in order to pair with the device in 30 seconds.
- 4. Then click **Scan** button, it will search for LT-20 device and click it which you would like to do settings as the following left picture. After pairing with the device, it would get settings.








5. Then FW version, LoRa MAC, device battery level, App Version would be shown at the bottom of menu. You could modify parameters by entering into each item of menu, for example, LoRaWAN, GPS, Operation Mode etc.






6. When entering into LoRaWAN settings, you could modify Join Mode, DevAddr, AppSKey, NwkSKey, Tx_Band etc. Please adjust these settings according to network server's settings carefully. Otherwise, it will cause network server connection issue. After modifying all the settings, click **Apply** button to write all these settings to the device.




If you are sure to apply the settings, click **Confirm** button, it will reboot automatically and interrupt BLE connection once saving all the settings successfully.





7. When entering into BLE Beacon/Wi-Fi Setting, you would see **Enable Ble Beacon(O2)** and **Enable Wi-Fi Scan AP(W3)** are on as default setting for new customer FW(F-0LR-3Q-2002271).




Please set **Enable Wi-Fi Scan AP(W3)** to 0 to disable it. LT-20 doesn't have Wi-Fi function, and only LT-20P could support it. It could support three kinds of beacon type: iBeacon, EddyStone_UID and AltBeacon.



White list Beacon ID could be used as mask. It is a filter for BLE beacons (white list) to be able to filter out unwanted BLE beacons.

For example, the user sets Beacon ID white list is "30000001". When the device receives any beacon signal which first 4 bytes of UUID are "30000001", the device will accept this data and send beacon report with this beacon's MAC Address. If the Beacon type is unmatched or the first 4 bytes of UUID are not matched with Beacon ID white list, the data will be dropped by the device. You could have 3 sets of ID for white list.






After modifying your settings, click **Apply** button and then click **Confirm** button to write your settings to device.

Please see the following table for white list length of each beacon type.

AltBeacon	1	20





 You could also adjust tracker's settings by modifying some parameters in GPS/ Operation Mode/Other Setting and click **Apply** button to write your settings to device.





9. In case if you have the wrong settings and would like to return to factory default settings, please click **Restore** button as the following left picture. However, you will lose all values customizations.








4.4 Firmware Upgrade via iOS App


I. Put firmware file to firmware upgrade tool via iTunes


- 1. Download iTunes for Windows system and connect mobile device with PC.
- 2. Allow the access for iTunes to connect to mobile device by responding ok in its screen.
- 3. Execute iTunes and click red square as following picture.






4. Click Apps and select LT-20 folder.








5. Drag the firmware file (zip file) to the right side which is called LT-20 Documents and click **Done** button.









II. Upgrade Firmware via iOS App

- 1. Make sure you turn on BLE for mobile device and open LT-20 App.
- 2. After device turned on, press function button for 2 seconds, then BLE LED will blink twice and release function button in order to pair with the device in 30 seconds.
- 3. Open LT-20 App and click **Scan** button. It will search for LT-20 device and then click it which you would like to do firmware upgrade as the following picture. After pairing with the device, it would get settings.






 Click Firmware Upgrade. Then click Select button and click the firmware zip file, for example, F-0LR-2Q-1912301_dfu.zip which had been put via iTunes. Then click Apply button.





5. Click **Confirm** button to do firmware upgrade. When finishing FW upgrade, it will show Upload complete as the following right picture. Click **Confirm** to exit it.
